The payment schedule shall be as follows:

- 1. 10% of the **contract price payable** to contractor on Submission and approval by KPC of a comprehensive engineering survey report with functional design specifications, implementation plan, and confirmation of order of equipment.
- 2. 20% of the **contract price payable** to contractor after Successful completion of Training and FAT on the Fire Alarm Systems.
- 3. 30% of the **contract price payable** to contractor upon the supply and delivery of Fire Alarm System equipment, Test Gear, Engineering tools, accessories, and spares for the Fire Alarm System.
- 4. 30% of the **contract price payable** to contractor upon successful installation, testing and commissioning of the Fire Alarm Systems.
- 5. 10% of the **contract price payable** to contractor on submission of as built drawings, Equipment manuals/documentation and warranty certificate.

Each payment shall be subject to 10 % retention until the 12 months warranty period after commissioning is complete and all defects noted are rectified to the satisfaction of KPC and prevailing KRA withholding tax rates.
